Please provide two recent ballet photos - 1st arabesque on pointe and tendu a la seconde and a headshot. Photographs should be at least 5"x7" and will not be returned.

Audition Attire

Girls - Black leotard, pink tights, ballet slippers and pointe shoes.

Boys - White t-shirts and full-length black tights, white socks and white ballet slippers.

Alternate Audition Appointment and Video/DVD/YouTube Submissions

If unable to attend audition date and you would like to request an audition appointment, or to submit an audition video/DVD or a YouTube link, please contact us at mme@akhmedovaballet.org or on Facebook at **Akhmedova Ballet Academy**.

Video submissions should be approximately 10-15 minutes in length and demonstrate barre and center exercises, including adagio, tendus, pirouettes, grand pirouettes, petit, medium, and grand allegro, tours en l'air for men, fouettes and pointe work for ladies. You may also include a classical ballet variation. For the first 2 minutes of the video, you should introduce yourself, state your age, the number of years of ballet/dance study, the number of years of pointe work (if applicable), the name(s) of your current school and teacher(s), programs or ballet competitions in which you have participated. The attire should be black leotard and full-length pink tights for ladies and a white shirt and black tights for men. **Audition video submissions deadline for Summer Intensives and year around program are due by March 1, 2021.**

Audition Fee: The audition fee is \$40 cash or check. The fee is nonrefundable. Unregistered applicants will not be considered. Please mail the registration form and audition fee to:
